Along with the shortcomings presented by the previous solution, it was also no longer going to be compliant in the way our client used it, so the team started looking for something better and easier to use – ideally at a lower cost.


#### Search for a Solution

With the global search/replace function, the policy and procedure creator only needs to change one piece of content which can then make a sweeping update across all policies and procedures that include it.
